

CHAMPIONSHIP CLASSES

Each 36-week Orange Ball class is \$1332 or \$1260 if enrolled by August 24th. Each Green Ball, Yellow 1 & Yellow 2 Championship class is \$1746 or \$1674 if enrolled by August 24th.
